

# How to read "the Notification"

This notification is calculated and composed based on your information as of June 3th about your insured status, total income etc. of the previous fiscal year (based on report for resident's tax or income tax), existence of an account and special payment through deduction from the pension. (For those households who moved in or moved out on and after the reference date, the notification of the change will be sent in and after July.)

※Base amount = total income of year 2022 – Base deduction ¥ 430,000

Please use this reference number for inquiries.

Your annual premium for the period between April 2023 and March 2024 is to be paid in ten installments from June to March. For those households who don't pay by automatic transfer, five payment slips from June to October and a prepayment slip for the whole period between April 2023 and March 2024 are enclosed. Payment slips for on and after November will be sent in November.

A notification of the premium is sent to the head of a household. Premiums are calculated per household. The head of a household is responsible for the payment of premiums. If anyone in your family is a member of the NHI scheme, the head of your household is obliged to pay the premiums even if he/she is an insured register of another health insurance scheme. Therefore the notification of the premium is sent to the head of your household.

**- You may have not filed for resident's tax return or income tax return.**  
 A NHI Premium is calculated based on your income for the previous fiscal year. A per capita premium can be reduced in case a household's income is below a certain fixed amount. (See page 14 of "NHI Guide")  
**The reduction won't be done unless you report for your taxes, because your income won't be finalized.**  
 We will send a NHI Premium Simplified Tax Form to foreign residents who have not reported for tax yet, so please submit it.

**- You may moved in on and after January 2nd.**  
 A notification of enrollment for the insured registers who moved in Meguro City on and after January 2nd of 2023 is only per capita premium.  
 After the income of the insured registers for the previous year is finalized, we will calculate his/her per income premium etc. and send him/her a notification of a change in his/her premiums later.
